Update on 2019 Project Connect

Project Connect is in disarray

- Harrison Pierce resigned effective 10/11/19
- Much work has yet to begin
- Proposal: move Project Connect to coincide with 2020 Point-in-Time count
 - January 29, 2020
 - Natural synergies with connecting with people experiencing homelessness
 - Would allow for new OCPEH Temp Employee to be hired and event planning

Continuum of Care (CoC) & Emergency Solutions Grant (ESG) Update

Both CoC & ESG applications submitted

- CoC application submitted to HUD on September 30 for \$730,285
 - \$34,014 short of available funding
- ESG application submitted to State ESG Office on October 11 for \$100,000
 - Written Standards will be updated to include all required elements at Nov. 18 Leadership Team meeting
