Homeless Management Information System (HMIS) Advisory Board Membership

HUD requires communities to use a database call the Homeless Management Information System (HMIS) — Orange County uses the HMIS@NCCEH implementation of this system. The HMIS@NCCEH Governance Charter states that the HMIS Advisory Board is made up of two designated representatives from each Continuum of Care (CoC), plus other members. Corey Root and Debra Vestal, Permanent Supportive Housing case manager at IFC, have served for several years. With the addition of another CoC-level staff person, staff asked the Leadership Team to consider appointing Rachel Waltz in the second CoC designated seat, replacing Debra Vestal. Staff will seek representation on the HMIS@NCCEH Advisory Board from IFC in one of the at-large seats.
