6:10-6:15 Homeless Management Information System (HMIS) Advisory Board Membership

HUD requires communities to use a database called the Homeless Management Information System (HMIS) – Orange County uses the HMIS@NCCEH implementation of this system. The [HMIS@NCCEH Governance Charter](#) states that the HMIS Advisory Board is made up of two designated representatives from each Continuum of Care (CoC), plus other members. Leadership Team appointed Rachel Waltz to the CoC seat in June. Staff is asking Leadership Team to appoint OCEPH Coordinator Kat Wies to seat vacated by Corey Root.

6:15-6:45 Racial Equity follow up Discussion

The Leadership Team completed Racial Equity training in June 2021. The Racial Equity committee requested a proposal for additional training. Leadership Team will review proposal submitted by coach and racial equity consultant, Jamall Kinard, to determine next phase of racial equity work. The Breakpoint Initiative offers two options – six month training and eight virtual trainings and 12 month training with 16 virtual trainings.

6:45-6:50 Emergency Solutions Grant (ESG) FY 21-22 RFA

The State ESG Office issued a Request for Applications (RFA) for FY 2021-22 Emergency Solutions Grant (ESG) on July 6. Orange County is eligible to apply for \$101,315 for shelter, street outreach, rapid re-housing, prevention, and Homeless Management Information System (HMIS), and administrative costs. Staff will review the ESG FY21-22 timeline, including the Leadership Team vote on recommended funding at the next meeting of the Leadership team on September 20, 2021.
