10 households presented for services, 1 household was diverted. 7 VI-SPDATS were completed, with 4 living outdoors and 3 in shelter. All signed consents, and 3 scored 4-7 and 4 scored 8-17.

Update on Coordinated Entry

The Coordinator gave an overview and update on coordinated entry, including the launch of the Homeless Hotline.

Coordinated Entry systemizes and standardizes services. The 4 key elements of CE are access, assessment, referral, and prioritization. Ideal systems stabilize emergencies efficiently and effectively. There are two parts: where is someone going to sleep tonight, and how are they going to return to permanent housing? These happen through diversion/emergency shelter and through case management.

We prioritize because there are not enough resources to serve everyone. Before, the people with the least need were getting served because they were the ones that were able to make appointments and follow rules to get access to these resources. Now, we are prioritizing resources by those that are the most vulnerable in the community that need the resources the most. This method of resource allocation allows those that only need a light touch to get that assistance, and those that need case management and rental assistance to also get that. Prioritization is happening through multiple streams and avenues.

We want to serve people as well as we possibly can with the right resources the first time. Also, we want to standardize the process so it doesn't matter where someone presents or at what time, but everyone gets the same access to resources.

People are not better off entering our system, so we want to divert people and prevent them from entering into homelessness in the first place, which reduces harm and empowers people to find a safe place. There are a lot of people that can self-resolve if we provide them a space to do so.

Some people will need rapid rehousing or permanent supportive housing depending on their level of need, chronic homelessness status, disability, etc.

The homeless hotline is imminent, and coordinated entry is being constantly refined. There are possible staff positions through the IFC project application and CoC planning grant.

DSS wants to continue RRH. Local funds are used to support the current caseload, but no state funds are coming to the office. DSS plans to apply for RRH funding. That funding does not come with funds for staff, so current staff are being diverted for case management, which is not a best practice. Nancy Coston could provide more information for the folks that were in the program that have not found permanent housing yet. Cannot take new referrals.

Board Development

Leadership Team members were asked to brainstorm potential board members to fill recommended categories for the 2019 Leadership Team. Going forward, the Board Development Committee will prepare a proposed slate of 2019 Leadership Team members for the November 19 meeting.

The coordinator will solicit Leadership Team member applications. BDC will meet to review applications and the LT votes on 2019 slate for Chair, Vice Chair, and new members. Non-elected official LT members serve 2 year terms. Can have 25 members, and we currently have 21. 4 folks can return and 2 cannot. Coordinator will contact members with greater than 50% absences to discuss next steps. Most HUD recommended categories on 2019 leadership team (list). Some categories don't exist in OC. We are missing some categories, some could be strengthened, and others would be great if they came online.
