Coordinating referrals

- Review of current process
 - SOAR referral form filled out, sent to Carmen
 - When Carmen has availability, she takes highest person on HOME list
- Change process to have mix of acuity in Carmen’s caseload?
 - Suzanne will discuss with Carmen and come to March meeting with proposal
 - Revised process
 - For each month take 2 new cases
 1. Highest number on HOME list
 2. Person from waitlist (on or off of HOME list, regardless of referral agency)

 - Add third party contact info for clients who are hard to get in touch with
 - Add last date worked next to employment status
 - Fine to fill in as much as folks know, leave other parts blank
 - Take off mental illness clause from functional areas
 - Adding Trans and Gender Nonconforming to gender choices and gender-neutral language
 - Remove race and other unneeded categories
