# Emergency Solutions Grant FY 20-21 RFA



#### State ESG Office released ESG FY20-21 RFA on August 17

- \$101,825 available for Orange County
  - Maximum of \$61,095 for Crisis Response
    - Street Outreach
    - Emergency Shelter Operations
    - Emergency Shelter Services
  - Minimum of \$40,730 for Housing Stability
    - Rapid Rehousing
    - Homelessness Prevention
  - 2 other eligible categories
    - Homeless Management Information Systems database
    - Administration for fiscal sponsors and local units of Orange County Partnership to End Homelessness
